

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **IGNACIO RAMOS, also known as IGNACIO RAMOS, JR.**, was convicted in the United States District Court for the Western District of Texas on an indictment (Docket No. EP-05-CR-856-KC (1)) charging violation of Sections 113, 242, 924, 1512, 7, and 2, Title 18, United States Code, for which a sentence of 132 months and one day of imprisonment, three years' supervised release, a fine of \$2,000.00, and a special assessment of \$600.00 was imposed on October 19, 2006; and

WHEREAS the said **IGNACIO RAMOS, also known as IGNACIO RAMOS, JR.**, was resentenced by the district court on November 13, 2008, following the vacation of his convictions for violation of Section 1512, Title 18, United States Code, by the United States Court of Appeals for the Fifth Circuit, to a sentence of 132 months and one day of imprisonment, three years' supervised release, a fine of \$2,000.00, and a special assessment of \$400.00; and

WHEREAS the said **IGNACIO RAMOS, also known as IGNACIO RAMOS, JR.**, has been confined continuously since his voluntary surrender on January 17, 2007, and is presently incarcerated at the Federal Correctional Institution in Phoenix, Arizona; and

WHEREAS the said **IGNACIO RAMOS, also known as IGNACIO RAMOS, JR.**, filed a petition for commutation of his prison sentence, seeking his release from prison; and


WHEREAS the ends of justice do not require the said prisoner to remain confined until his currently projected release date of August 11, 2016, and the safety of the community will not be compromised if he is released before that date;

NOW, THEREFORE, BE IT KNOWN that I, **GEORGE W. BUSH**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant the said application and commute the prison sentence imposed upon the said **IGNACIO RAMOS, also known as IGNACIO RAMOS, JR.**, to expire on March 20, 2009, leaving intact and in effect the three-year term of supervised release with all its conditions and all other components of the sentence.

WHEREAS **JOSE ALONSO COMPEAN** was convicted in the United States District Court for the Western District of Texas on an indictment (Docket No. EP-05-CR-856-KC (2)) charging violation of Sections 113, 242, 924, 1512, 7, and 2, Title 18, United States Code, for which a sentence of 144 months' imprisonment, three years' supervised release, a fine of \$2,000.00, and a special assessment of \$800.00 was imposed on October 19, 2006; and

WHEREAS the said **JOSE ALONSO COMPEAN** was resentenced by the district court on November 12, 2008, following the vacation of his convictions for violation of Section 1512, Title 18, United States Code, by the United States Court of Appeals for the Fifth Circuit, to a sentence of 144 months' imprisonment, three years' supervised release, a fine of \$2,000.00, and a special assessment of \$400.00; and

WHEREAS the said **JOSE ALONSO COMPEAN** has been confined continuously since his voluntary surrender on January 17, 2007, and is presently incarcerated at the Federal Correctional Institution in Elkton, Ohio; and

WHEREAS the said **JOSE ALONSO COMPEAN** filed a petition for commutation of his prison sentence, seeking his release from prison; and

WHEREAS the ends of justice do not require the said prisoner to remain confined until his currently projected release date of June 24, 2017, and the safety of the community will not be compromised if he is released before that date;

NOW, THEREFORE, BE IT KNOWN that I, **GEORGE W. BUSH**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant the said application and commute the prison sentence imposed upon the said **JOSE ALONSO COMPEAN** to expire on March 20, 2009, leaving intact and in effect the three-year term of supervised release with all its conditions and all other components of the sentence.
